- iv. Capival is authorized to use and share data and information spooled from your transaction with affiliated third parties for compliance and verification purposes.
- v. You hereby grant Capival and third-party affiliates as your lawful attorney-in-fact for You, in your name, place and stead to retrieve information, access servers and documents with the full authority to act in accordance with the company's requisites and necessities on your account.
- vi. You agree to notify us immediately in cases of concerns and suspicions that the confidentiality of information have been compromised.
